**Rule 20. Failure to appear at the calendar sounding to advise the judge or appropriate calendar clerk may result in the following disposition: (A) In civil actions, the dismissal without prejudice of plaintiff's action or defendant's answer, counterclaim, or cross claim; and, (B) In criminal cases, the acquitting of the accused defendant or the dead docketing of the case.
