ORDER SCHEDULING PEREMPTORY CALENDAR

The statements of claim listed on the accompanying calendar have been pending for 6 months or more, and (1) service has not been perfected and/or (2) the matter remains unresolved following service on the Defendant and the filing of an Answer. It is the Court's intention to bring the cases to a conclusion by trial, consent judgment, or dismissal.

All parties on the calendar shall appear to announce the status of their cases at the Horace J. Johnson, Jr. Judicial Center, 1132 Usher Street, Covington, Courtroom A, Georgia, 30014, on Thursday, October 31, 2024, at 9:00 a.m.

Failure to appear for the call of the calendar by the Plaintiff may result in dismissal of the action for want of prosecution. Failure to appear for the call of the calendar by the Defendant may result in the Answer being stricken and dismissal for want of prosecution for any counterclaim or cross-claim.

Parties who are represented by counsel do not have to attend the proceeding with their attorney of record. However, any party that is not represented by an attorney must appear.

Continuances will be granted on a very limited basis and only for good cause shown. Written motions for continuance must be filed with the Court no less than 3 business days before the calendar.

Dismissal of any case or consent judgements prior to the calendar must be filed with the clerk before 4:45 p.m. on the day before the calendar in order to be effective.

All attorney conflicts will be resolved as provided in Uniform Magistrate Court Rule 8.1. Attorney leaves of absence filed after the calendar is published will require an application and Court approval pursuant to Uniform Superior Court Rule 16.2.
